

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.tendertransitions.net and Tender Transitions and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Tender Transitions include www.tendertransitions.net. The Tender Transitions website is a small business site. By using the Tender Transitions website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Tender Transitions may collect personally identifiable information, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. Use of your Personal Information

Sharing Information with Third Parties

Tender Transitions does not sell, rent or lease its customer lists to third parties.

All such third parties are prohibited from using your personal information except to provide these services to Tender Transitions, and they are required to maintain the confidentiality of your information.

Right to Deletion

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen

Tender Transitions does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
